7:45 p.m. Cont. Notice of Intent: 217 Summer St, DEP 337-1436; Howe Development Corp.

The applicant has filed this Notice of Intent for the construction of several additions to the existing single-family dwelling, including a new deck, two balconies, an extension to the existing attached garage, extension of the existing driveway, and replacement of the existing sewage disposal system. A portion of the proposed work falls within the 100-foot Buffer Zone to a Bordering Vegetated Wetland and the 200-foot Riverfront Area to a perennial stream

8:00 p.m. Cont. Notice of Intent: 355 Highland Street, DEP 337-1435; N. Keramaris

The applicant has filed this Notice of Intent for the removal of the existing dwelling and construction of a new single-family dwelling and its appurtenances. Proposed work within 100-feet of a Bordering Vegetated Wetland includes grading associated with the construction of the proposed dwelling, construction of a portion of steps with retaining walls, construction of a subsurface drainage structure and associated drain

lines, constructed of a fence, and tree clearing as well as invasive plant removal and replanting.

The Applicant has filed this Abbreviated Notice of Resource Area Delineation for confirmation of jurisdictional resource areas on the subject parcel. The site contains Bordering Vegetated Wetland and its 100-foot Buffer Zone, Bordering Land Subject to Flooding, and Riverfront Area.

The Applicant has filed this Request for Determination of Applicability for the repaving of an existing driveway. A portion of the proposed work falls within the 100-foot Buffer Zone to a Bordering Vegetated Wetland.

8:45 pm Request for Amendment to Order of Conditions 337-1443: 115 Country Drive, J. McGeough*

The Applicant has filed this Request for Amendment to Order of Conditions 337-1443 for construction of a boulder retaining wall, installation of a secondary construction access point, and restoration of grading that was done beyond the approved limit of work. A portion of the proposed work falls within the 200-foot Riverfront Area to a perennial stream.
