Approve a request from the Weston Police Department to accept a gift of \$2,500 from Mr. and Mrs. Josef J.D. Gazzola to be applied to the Josephine Gazzola Advancing and Supporting Women in Law Enforcement fund.

Approve a request from the Weston Public Library to accept the distribution of \$8,500 from the Nathalie and Theodore Jones Charitable Trust to be applied to the Library General Purposes Fund.

Authorize Town Manager to Sign the Regional Housing Services Office Agreement for 2021-2022.

Update Weston Service Program Policy to increase the hourly rate to match the Massachusetts minimum wage of \$13.50 per hour.

Renew Fire Chief and Forest Warden David Soar's contract effective February 11, 2020 to February 10, 2023.

Lift the muzzle order placed on Layla, the golden retriever belonging to Kelley Murphy.
